Any conflict between requirements of this Material Specification and Material requisition supplementary design data, Standards, or Codes etc, shall be referred to Owner for clarification, before proceeding with the fabrication of the affected part.

Gasket Vendor shall be responsible to design fabricate and supply gaskets in

accordance with requirements of applicable documents.

In no event, however, dimensions thicknesses etc., are to be less than those required by standards, unless specific written approval to the contrary is received from Owner.

#### 2.0 GENERAL REQUIREMENTS

2.1 STANDARD

ELOT EN 12560 (parts 1-4) and ELOT EN 1591-1

For Flanges ELOT EN 1759-1 applies. For flanges with DN>600 not covered by this standard, dimensions given in ASME B16.5 apply.

TYPE AND MATERIAL 2.2

Spiral Wound, for raised face flange as per ELOT EN 1759-1 table 3b, asbestos free, graphite, filled X5CrNiMo17-12-2 (stainless steel 1.4401, ELOT EN 10088-3) winding and inner ring. Carbon Steel solid ring type centering device.

**MARKING** 2.3

As a minimum the marking shall include:

- Vendor's mark.
- Type and Materials.
- ELOT EN 12560 (parts 1-4)
- Size and primary pressure rating class.
